- The attached Invitation List must be filled out completely, and returned with the Waiver of Liability forms for each "star". **They must be postmarked by April 1, 2017 and mailed to Attn. Amanda Noah, Silverwood Theme Park 27843 N. Hwy. 95 Athol, Idaho 83801.**
- **Late registration will not be accepted.**
- Additional family members may purchase tickets for \$12.00 (\$11.32 plus.68 tax) at the gate the night of the event, and meal tickets for \$3.00 (\$2.83 plus.17 tax) in the Courtyard or at the Pavilions where the meal is being served at the south end of the park.
- If you or anyone you know is not accompanying a "star" but would like to volunteer to help with the event please fill out the enclosed volunteer list and return with the paperwork by the deadline.
- **ONLY "STARS" NEED TO SIGN A WAIVER OF LIABILITY.**

# Night of Stars Check List

(Please be sure to read the complete check list below)

## ▪ Invitation List-

- Invitation list is for organization use only, not to be sent home with Stars or family members.
- All organization information must be filled out in full on the invitation list.
- Stars name must be in the star column and guest name in the guest column. Star and guest name can only be on the invitation list one time.
- Invitation list must be typed or printed legibly with full pages, not several partial pages.
- If it cannot be read it will not be accepted.
- Invitation list must have first and last name of guest and star. If no name is put or you just write in “guest”, the star only will receive a ticket.
- Please send all Invitation lists and releases in at one time. Only one mailing from each organization will be accepted.

## ▪ Release Forms –

- Release forms must be filled out completely.
- Releases must be signed by Star or Legal Guardian.
- Please make sure releasers name is on the correct line and the parent or legal guardian is signed on the correct line. No release is required for the guest.

## ▪ Silverwood admission tickets and meal tickets –

- Please make sure each star and their guest receives a Silverwood admission ticket and a blue meal ticket. There will be no free admission or meal tickets at the gate.

*\*It is your responsibility as an organization to ensure that each star and their guest receives their ticket and blue meal ticket.*

RELEASE OF LIABILITY

PLEASE READ CAREFULLY BEFORE SIGNING. AFTER SIGNING RETURN RELEASE FORM TO THE ORGANIZATION YOU RECEIVED IT FROM.

I understand that the purpose of "Night of the Stars" is to provide individuals with special needs, including physical or mental disabilities, hereinafter referred to as the "Stars", the opportunity to enjoy Silverwood Theme Park without charge. In consideration of receiving complimentary admission to Silverwood Theme Park's Annual "Night of Stars," the undersigned, for him/herself, their spouse, legal representatives, heirs and assigns, hereby waives, releases and discharges Silverwood Theme Park, Silverwood Inc., its officers, agents, employees, principals, and each of them, from any and all liability to the undersigned, his spouse, legal representatives, heirs and assigns for any and all loss or damage, and any claim or damages resulting where from, on account of injury to the undersigned's person or property, even should such injury result in death, whether caused by the negligence of the Releasees or otherwise, during the undersigned's visit to Silverwood Theme Park and the use of any and all of its facilities, rides, or attractions on May 12, 2017. The undersigned further agrees to indemnify all releases from any loss, liability, damage or cost that any Releasee may incur due to the entrance, admission and use of the facilities, rides and attractions of Silverwood Theme Park.

The undersigned specifically acknowledges and agrees that in consideration of Silverwood's charitable efforts to accommodate a large group of disadvantaged and disabled persons, the undersigned waives and agrees to fully release and hold harmless Silverwood Theme Park from any claims arising out of or involving in any way a preexisting disability or impairment of the Star or their guests, including waiver of any claims that could be made under the Americans with Disabilities Act or any other state, federal or local rule relating to persons with disabilities or impairments.

The undersigned hereby assumes full responsibility for the risk of any bodily injury, death or property damage due to the negligence of Silverwood Inc., its officers, agents, employees or principals while in or upon Silverwood Theme Park. Further, the undersigned expressly agrees that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the law of the State of Idaho, and that in the event any portion thereof is held invalid, it is agreed the balance shall, notwithstanding, continue in full force and effect.
