SNR Scholarship FAQ

Who is eligible for scholarships?

All SNR participants, no matter, their age, sex, housing situation, or race are eligible for SNR Scholarships. We encourage all who think they may benefit to apply.

What do the scholarships cover?

Camp All Stars: This scholarship covers the \$25 a day fee for camp. This can be applied to Summer, Winter, and Spring break camp, at full or partial funding (specify on application).

Evening Group: Scholarships will be awarded in the form of a pre-paid punch card, redeemable at SNR Evening Group activities. Evening Group attendance is \$10, participant is responsible for activity fee (dinner, movie, bowling, etc.).

LIFE Group: Participants will be given the option to receive account credit or a prepaid punch card. Daily attendance is \$10, participant is still responsible for activity fees (bowling, lunch, movie, crafts, etc.)

Dorothy Gallus SNR Sports Scholarship: Mini sports sessions are offered periodically throughout the year, such as basketball, soccer, and flow boarding. The sessions are \$25 each.

When can I apply for a scholarship?

Each scholarship has different application windows.

Camp All Stars: April 1st-30th

Evening Group: July 1st-July 30th (participant is responsible for activity fees)

LIFE Group: November 1st- November 30th (participant is responsible for activity fees)

Dorothy Gallus SNR Sports Scholarship: ongoing, preceding each sports session.

What do I need to fill out a Scholarship Application?

Participants must have an updated registration form on file to be considered for scholarships. Applications will be denied otherwise.

We encourage participants to be involved in the application process. If the participant needs assistance with writing, that is allowed, and extra sheets of paper may be added to the application.

Make sure to fill out the LMI section of your registration paperwork, this helps us calculate total scholarship dollars awarded.

How are scholarships determined?

SNR has recruited a Scholarship Committee of community members and business professionals to determine scholarship eligibility to maintain fairness and to make unbiased decisions. Scholarship acceptance will be determined by financial need and participant's scholarship benefits answer.

What can cause an application to be denied?

While we don't want to turn anyone away, there are things that can cause an application to be automatically denied. These things include:

Late application submittal, unfinished application submittal, no updated registration on file.

Are there requirements to keep and maintain my scholarship?

Yes. We require participants who receive scholarship funds to attend A MINIMUM of 20% of the program they are receiving funds for. All scholarship recipients must be in good standing with our Code of Conduct. Infractions of the Code of Conduct may result in loss of scholarship funds.

We require all scholarship recipients to volunteer with SNR for 2 hours a year. Volunteering may include assisting in event set up, or SNR facility upkeep. Volunteer duties will be arranged at the time of scholarship acceptance.

Is there a way to apply for a partial scholarship?

Yes. Applicants can choose if they would like 25%, 50%, or 100% of the allocated scholarship amount.

Do I need to fill out a different application each year?

Yes. SNR requires a new application to be submitted each year.

Do I need to fill out an application for each scholarship if I am applying for multiple scholarships?

Yes. You are welcome to apply for any scholarship during the desired open window.

Will I receive cash based on scholarship approval?

No, scholarship funds will either be put on as an account credit or provided as a punch card, depending on the scholarship.

Am I eligible for a future scholarship if I have to forfeit scholarship funds?

It depends on the circumstances, The reason for forfeiting will determine if a participant is eligible in the future. If a participant must forfeit a scholarship for things like family emergencies, or situations out of their control, they can be eligible in the future. If a participant loses their scholarship due to Code of Conduct violations, not meeting attendance requirements or not completing mandatory volunteer hours they will not be eligible in the future.

How will I know if I received a scholarship?

We will email the participant's payee informing them of the acceptance and what percentage of the scholarship they will be receiving within 30 days of the application closing window. This is why we require the payee email on the Scholarship Application.

What if I would like to request a scholarship and the windows open are not relevant to the program I'm requesting?

In the event that you would like to request scholarship support outside of the window, please contact the executive director. We will do our best to find a solution.

How do I turn in a Scholarship Application?
